

VADODARA/SURAT: Bike-borne miscreants are having a field day in festive season, puncturing claims of increased patrolling by city police.

Two women and a 10-year-old girl were targeted by robbers in different areas since Friday.

Priya Prakash, 30, a resident of Piplod, was targeted by two persons on a motorcycle who snatched her bag when she was going on her scooter near Florence Hospital. Prakash fell on the road when they snatched her bag, but when she tried to get up, one of them stabbed her in the right leg with a knife. They escaped with her bag containing cash and mobile

phone total worth ₹ 25,600.

In another incident near city bus depot, two robbers on a motorcycle snatched a bag that contained cash and jewellery worth Rs 85,000 from the hands of a 10-year-old daughter of a

diamond unit employee early on Saturday morning. The girl had reached the depot with her family at around 4.15 am in an auto rickshaw to board a bus for their native in Banaskantha. Her father Rakesh Prajapati was collecting luggage from the rickshaw and asked her to hold the bag with valuables for a while. Within seconds after they got down from the rickshaw, the robbers snatched the bag and fled.
